

Medicare Benefits Schedule Changes for Audiology Items Commencing 1 March 2023

Last update: 28 March 2023

Background

The Medicare Benefits Schedule (MBS) Review commenced from 2015 to 2020 with the aim of improving the MBS by aligning MBS items with contemporary clinical evidence and practice to improve health outcomes. On 14 December 2020, as part of the MBS Review, the MBS Review Taskforce Clinical Committee made six recommendations for Audiology Items on the MBS, which were presented to the Australian Government for endorsement.

The Australian Government endorsed all recommendations provided by the MBS Review Taskforce Clinical Committee. The MBS Review Taskforce recommendations are as follows:

1. Reduce referral restrictions for audiology item numbers performed by an Audiologist.
2. Create new items which reflect the different clinical uses of brain stem evoked response audiometry and implant processor programming and broaden the application to include all implantable hearing devices.
3. Consolidate items for impedance audiograms.
4. Include the assessment of outer hair cell function in the cochlea in the application of oto-acoustic emission audiometry.
5. Restructure vestibular assessment items to reflect current practice and to future proof for evolving clinical practice.
6. Improve access to services by availing telehealth.

Upcoming changes on 1 March 2023

From 1 March 2023, changes to the following Audiology Items will come into effect as part of the Australian Government's implementation of the MBS Review Taskforce recommendations. **Importantly, this includes a change in the written request requirements for the following Audiology Items: 82300, 82306, 82309, 82312, 82315,**

82318, 82324 and 82332. From 1 March 2023 and onwards, the written request requirements will be broadened to include any medical practitioner as eligible to provide a written request to an audiologist.

The following items may be performed by an audiologist on behalf of a medical practitioner or a specialist or consultant physician.

The following items may be performed by an audiologist for the assessment and treatment of Complex Neurodevelopmental Disorders and eligible disability services.
